YOUR SUPPORT IS URGENTLY NEEDED

We would like to once again advise our club membership that some members of the Canadian Veterinary Medicine Association (CVMA), through its provincial associations, continue on their push to implement a Veterinarian ban on cropping, docking and dew claw removal. The GSPCC has sent letters to the Canadian Kennel Club objecting to the CVMA calling the procedures of tail docking and dew claw removal as cosmetic (copy of our club's letter was mailed to the membership in 2009).

At this time, we urgently need you to show your support by writing to the College of Veterinarians of British Columbia by their established deadline of November 1st. For more information visit www.cvbc.ca and go to the tab General Topics. We will be sending you a separate email with a suggested letter to mail.

Please join us in saying **NO** to the Canadian Veterinary Medicine Association (CVMA) and its provincial associations, on their push to prevent those Veterinarians from offering the services of tail docking and dew claw removal to their breeder clients.

Minutes of the Board Meeting of June 2010

Following are the minutes of the June Board Meeting for the membership to review and offer their comments.

1. Addition of a Code of Ethics to our Constitution

Moved by Tammy Parris: that the board accept the COE as drafted by Maxine Moinier. That the Puppy Socialization Chart not be part of the COE but be available to breeders to hand to puppy buyers and be available on the club's website.

2. Online Newsletters

Moved by Tammy Parris: to accept the online version of the G.S.Paws newsletter replacing the printed one as a cost savings to the club. For those members who do not chose the online version, a printed copy will be mailed to them.

For: 8 (TP, MM, NK, DN, AD, MF, RI, SS, KI) Against: 0 Abstain: 2 (LK, BT) - Motion carried.

3. Increasing Membership

Proposal by Janna Jackson to increase membership by offering a free membership to new puppy purchasers of existing members in good standing.

For: 8 (TP, DN, AD, RI, MM, NK, MF, SS, KI) Against: 0 Abstain: 2 (LK, BT) - Motion carried.

4. Lifetime Achievement Award

Motion rejected as presented. Withdrawn. Motion has been re-submitted. To be tabled at next meeting.

5. National Specialty - Maritimes

Lynn Kearley-Munro advised that she is working with a small group to host the 2011 in the Maritimes and that more information will be provided to the membership when it is available.

6. Policy on Selection of National Specialty Judge

Discussion took place on the selection of the National Specialty Judge and the process to conduct a National Specialty including providing a budget in the planning stages of the event to the Board, and providing a financial statement once the event is complete.

7. Rescue service

Discussion took place on establishing a Rescue Service for the Club. This discussion is on-going and carried over from our February 2009 meeting. Although this agenda item was not put forward as a motion, we received 6 votes in favour of organizing a Rescue Committee. A proposal will be added to the next meeting agenda.

7A Position of Rescue Coordinator

Maria Foster proposed approaching Heather Brennan to become Rescue Coordinator as she has had extensive experience in doing rescue for the club in previous years and has also participated in rescue and fund raising for the Siberian Husky club.
